### TERMS AND CONDITIONS OF THE AGREEMENT:

This agreement dated\_\_\_\_\_, and when signed by both parties, is a legal and binding contract between the musical group known as 'Higher & Higher' (hereinafter referred to as the 'Group'), and\_\_\_\_\_, (hereinafter referred to as the 'Client'). The terms of this contract are set forth herein this document.

The Client agrees to hire the Group for the above engagement for the specified date(s) and hours listed above. During this specified period, the Group shall provide musical entertainment consisting of popular music performed by the members collectively referred to as the Group herein. The Group will take breaks appropriate to the occasion depending on the hours and type of event. The Group shall provide appropriate break music on CD between sets; any special, individual song requests must be supplied by Client. The Group agrees to provide the official Group members for this event and will perform an appropriate variety of stylized music (see Group Play List <http://www.higherandhigherband.com/Playlist.htm>) for the intended participating audience. In the event of any unforeseen catastrophic circumstance (i.e. death in the family, personal illness) that one or more of the 'original' Group members becomes unavailable for the event, the Group reserves the right and agrees to furnish adequate substitutes to adhere to the event requirements set forth in this agreement. Any musical selections requested by the Client must be presented to the Group one (1) month in advance to allow proper preparation of the song material prior to the event. The Group reserves the right to substitute a CD audio track for any of the special requested songs as needed. The Group agrees to dress accordingly for this event (Formal, Semi-Formal or Casual Attire). The Client may request additional musicians at a rate of **\$100.00** per musician, per hour. The Client must notify the Group at least 45 days in advance to allow for adequate time to secure the additional musicians and insure they are properly prepared.
